Petitioner's Group

Kim Chrestman spoke on how unfair the voting on the Smoking Policy was and was asked by a large number of staff members revisit the issue. They petition the Staff Members to take the following steps:

Guest Speaker: Vice Chancellor of Student Affairs, Dr. Brandi Hephner-Labanc

The Division of Student Affairs is aligned with different types of people who require having a Master's Degree or Doctorate. There are also Medical Doctors, Nurses, Lawyers, dedicated educators and staff members who take their work seriously in interacted with students outside.

Their job is to monitor how students are growing cognitively, psychosocially and morally and provide leadership development and travel support to those who show a positive future. They also support students and challenge them along the way on how to navigate the educational system at this university.
